**PETITION FOR SURRENDER OF THE PRINCIPAL
LICENSE OF JEFFREY WOSENOCROFT**

Pursuant to the Pennsylvania Race Horse Development and Gaming Act (“Act”)and the regulations promulgated thereunder, Philadelphia Entertainment and Development Partners, L.P. (“Foxwoods Casino Philadelphia”) hereby petitions the Pennsylvania Gaming Control Board (“Board” or “PGCB”) for leave to surrender the Principal License of Jeffery Wosencroft, former Managing Director of FDC/PEDP GP, LLC, the General Partner of Foxwoods Casino Philadelphia, without prejudice. In support thereof, Foxwoods Casino Philadelphia avers as follows:

1. Jeffery Wosencroft served as Managing Director of FDC/PEDP GP, LLC, until on or about April 2, 2010.
2. Mr. Wosencroft received his original principal license, Docket Number 29785, on November 4, 2009.

3. Mr. Wosencroft no longer holds any employment position with and has no ownership or other interest in, FDC/PEDP GP, LLC, or any affiliated entity, and is no longer required to be licensed or approved by the Board as a principal or otherwise.

4. Foxwoods Casino Philadelphia requests that the Board exercise its discretion grant this request by Foxwoods Casino Philadelphia to surrender the principal license of Mr. Wosencroft and to do so without prejudice to either Foxwoods Casino Philadelphia or any of its affiliates or Mr. Wosencroft.


5. Foxwoods Casino Philadelphia requests that the Board exercise its discretion and grant this request by Foxwoods Casino Philadelphia to surrender the principal license of Mr. Wosencroft and to do so without prejudice to either Foxwoods Casino Philadelphia or any of its affiliates or Mr. Wosencroft, and without conditions in any way limiting the eligibility of Foxwoods Casino Philadelphia or any of its affiliates or Mr. Wosencroft to apply to the Board for licensure or waiver as permitted by the Act or regulations promulgated thereunder.

6. For the foregoing reasons, Foxwoods Casino Philadelphia respectfully requests that the Board grant its petition and permit the voluntary surrender of Mr. Wosencroft's principal license, without prejudice or conditions.

WHEREFORE, Philadelphia Entertainment and Development Partners, L.P., d/b/a Foxwoods Casino Philadelphia respectfully requests that the Pennsylvania Gaming Control Board issue an Order granting its Petition for the voluntary surrender of Jeffery Wosencroft's principal license, without prejudice or conditions.


