Guide to Candidates on Casinos

Mayoral & At-Large City Council Candidates

Casino-Free Philadelphia does not endorse any candidates. However, many of them have endorsed us.

We believe that people's positions on casinos is indicative on their stance on neighborhood empowerment, democratic principles, and commitment to protecting the City from harmful social development. We encourage everyone to use this guide as people decide who and how to support the mayoral and at-large candidates.

In every case, all candidates were contacted and responses were published in the order received.

Philly's Ballot Box

Philadelphians know that development should have standards. No social standards protecting homes or neighborhoods are in place for casinos. Casino-Free Philadelphia crafted a minimum standard on casino development.

Twenty-seven thousand Philadelphians signed a petition calling for a vote on whether to have a 1,500 foot buffer zone between casinos and homes, schools and places of worship. The Philadelphia City Council voted unanimously to place this referendum, Question #1, on the May 15th ballot. The referendum would be legally binding, using the city's local zoning control, which was upheld by the PA Supreme Court.

The state Supreme Court is threatening our right to vote on the casino buffer zone. They have put a preliminary injunction on the referendum. Therefore, we plan on holding our own election so that Philadelphians will be able to vote on Question # 1.

As a result, Casino-Free Philadelphia is launching PhillysBallotBox.org.

Philly's Ballot Box is a citizens' ballot where on Election Day, May 15th, voters in Philadelphia will be given a chance to vote on the referendum. We will set up our own ballot boxes around the City and allow people to vote secure online and vote via phone.
